Base Metals prices finished higher yesterday on weaker dollar index and on hopes a more vigorous Chinese fiscal policy would spur growth.

BHP's Escondida mine in Chile said it had made a final offer in talks with the union representing its rank-and-file workers that includes a beefed-up contract signing bonus and a 1.5 percent increase in wages

Antofagasta on Wednesday reported a 6.1 percent increase in second-quarter copper production and a fall in costs, a trend the miner said would continue for the rest of the year.

Norwegian aluminium producer Norsk Hydro said the timing for resuming full output at its Alunorte alumina refinery in Brazil remained uncertain, with the possibility it could be achieved between October and the middle of next year..
