## **Precious Metals News**

Gold prices climbed higher as the dollar fell back on expectations the U.S. central bank may pause interest rates hikes if the U.S. economy slows this year

The worries of slowing domestic and global growth as well as tame U.S. inflation will make Fed policymakers hesitant to raise interest rates in the world's largest economy.

Theresa May must win a vote in parliament to get her Brexit deal approved or risk a chaotic exit for Britain from the EU. The numbers are not in May's favour and her chances of winning the vote look extremely slim.

Investors were also worried about a partial U.S. government shutdown over President Donald Trump's demand for \$5.7 billion to build a wall along the U.S.-Mexico border, which entered its 24th day today.

Physical gold premiums rose in China last week as investment demand firmed on worries over global growth and a softening dollar, though Indian buyers remained on the sidelines ahead of the wedding season.

## **Precious Metal Outlook**

Precious metals are trading higher in early trade. We expect precious metal prices to trade positive on worries over Brexit deal to be approved or rejected and at the same time worries of global growth slowdown. Strong ETF flows and central bank buying are supporting factor for gold prices.
