

• **Biocon Mgt Guideline :** Submission of Trastuzumab dossier to the United States Food & Drug Association (USFDA) is an important milestone for Biocon and the review process is expected to take 18-24 months

Huge opportunities exist for Biocon in the US biosimilars market. The company has also filed for 3 biosimilars with European Union regulator and is likely to file those with the USFDA too.

Discussing the Indian market, Mgt said while exports have not been impacted due to demonetisation, Indian business saw lower sales over the last month. Mgt added that dependence on domestic business is quite small.

Stopping sale of Abraxane has also impacted Indian business. Some decline in branded formulation business is expected on back of this

• **Cosyn** bagged an order from West Bengal State Electricity Distribution Company (WBSEDCL) for a value of Rs 34.44 crore. • Vedanta said that he wants to meet the country's growing demand and aims to produce 50 percent of India's oil needs. the government has not approached the company with regards to further stake sale in Hindustan Zinc and Balco. Cairn India is looking to invest Rs 30,000 crore in the next 3 years. On the rise in global crude oil prices, Company said that it is unlikely for the prices to move higher and sees it to range bound at around USD 50-60 per barrel. • **NBCC** has secured business worth Rs 24,694 crore during last month. The total business of Rs 24,694.23 crore secured in November includes re-development work of 3 GPRA colonies at Sarojini Nagar, Nauroji nagar and Netaji Nagar valued at Rs 24,682 crore based on the MoU signed with the Ministry of Urban Development.

• Adani Enterprises has incorporated its wholly-owned arm Adani Cementation . The company has incorporated a whollyowned subsidiary namely "Adani Cementation Ltd" (ACL) on December 06, 2016

• Lupin has received approval from the US health regulator to market generic Desoximetasone ointment, used to treat inflammation and itching, in the American market. The company's US-based subsidiary, Lupin Pharmaceuticals Inc, has received final approval for the product from the US Food and Drug Administration (USFDA)

• Australia's GDP fell to a seasonally adjusted -0.5%, from 0.6% in the preceding quarter whose figure was revised up from 0.5%. Analysts had expected Australia's GDP to rise 0.3% in the last quarter.

• **US Census Bureau** said factory orders rose 2.7% from 0.6% in September whose figure was revised from 0.3% . Analysts had expected factory orders to rise 2.6% in October.

• U.S. Factory Orders rose to a seasonally adjusted 2.7%, from 0.6% in the preceding month whose figure was revised up from 0.3%. Analysts had expected U.S. Factory Orders to rise to 2.6% last month.

• **ISM Non-Manufacturing PMI** rose to a seasonally adjusted annual rate of 57.2, from 54.8 in the preceding quarter. Analysts had expected ISM Non-Manufacturing PMI to rise to 55.4 in the last quarter.
