





### **Top News:**

- **Dr reddy** announced that it has launched Docetaxel Injection USP 20 mg/ml and 80 mg/ml a therapeutic equivalent generic version of Taxotere in U.S. market . Dr reddy's ANDA is approved by the united States Food & Drug Administration . Taxotere brand & generic has U.S. sales of approximately \$218 million .
- L&T Technology Services, the wholly owned subsidiary of \$14.3Bn Larsen & Toubro Group, announced that it has closed the acquisition of the assets of U.S.-based Dell Product and Process Innovation Services, the Engineering Services division of Dell ("Dell Engineering Services").
- Crompton Greaves Ltd has informed that Avantha Power & Infrastructure Limited (APIL) in which CG holds an equity investment of approx. 23.14% has informed that it has signed a Memorandum of Understanding with Adani Power Ltd. for 100 per cent sale of APIL's Korba West Power Company Ltd. (KWPCL). KWPCL, a SPV of APIL, is commissioning a coal based thermal power plant of 600 MW. KWPCL is valued in excess of Rs. 4200 crores.
- Fund Action :Bhartiya International : Morgan Stanley Asia buys 58,334 shares at Rs 410/- . Gujarat NRE Coke : Orange Mauritius buys 10.45 lakh shares at Rs 3.50/- & VCM Mauritius sells 10.45 lakh shares at Rs 3.50/- . INOX Leisure : Macquarie Asia New Stars Fund buys 6 lakh shares at Rs 182/- & Reliance Capital Partners sells 11.49 lakh shares at Rs 182.15/- . Rain Industries : Eastspring Investments India Infrastructure Equity Open sells 19.9 lakh shares at Rs 50/- & Goldman Sachs Investments Mauritius buys 22.24 lakh shares at Rs 50/sh . Titagarh Wagons : CAAM Funds India Infrastructure buys 1.30 lakh shares at Rs 320/sh . Rane Holding : Sundaram Mutual Fund Buys 1.86 lakh shares at Rs 570/- & Morgan Stanley Asia sells 2.62 lakh shares at Rs 570/
- Ballarpur Industries Ltd has informed that the Company and its step down subsidiary, Bilt Graphic Paper Products Limited are equity shareholders of Avantha Power & Infrastructure Limited (APIL). Korba West Power Company Limited (KWPCL) is a subsidiary of APIL. APIL has signed a Memorandum of Understanding with Adani Power Limited for sale of its entire shareholding in KWPCL. KWPCL has a commissioned coal based thermal power plant of 600 MW and is valued in excess of Rs. 4,200 Crores. APIL is company promoted by Avantha Holdings Limited, Crompton Greaves Limited and the Company.
- KNR Construction announced that their 51:49 JV with Tomar Builders & Contractors has been award by Madhya Pradesh Road Development Corporation of Madhya Pradesh an orders worth Rs 109.56 Crore . The order is 12.13 % of sales .
- Adani Power entered into a binding agreement with Gautam Thapar-led Avantha Group to buy out its 600 MW Korba West unit for more than Rs 4,200 crore. This is the second acquisition by Adani Group since it bought the Rs 1,200 MW coal-fired Udupi plant from the debt-laden Lanco Infra for Rs 6,000 crore in August.
- Jindal Steel & Power Ltd has shelved a USD10 billion coal-to-diesel project, becoming the first big casualty of a Supreme Court decision to scrap coalfields allocated to private firms since 1993.
- **Taiwanese Industrial Production** fell to a seasonally adjusted annual rate of 8.97%, from 10.30% in the preceding month. Analysts had expected Taiwanese Industrial Production to fall to 7.50% last month.
- **German business confidence** improved unexpectedly in November, Business Climate Index rose to a seasonally adjusted 104.7 this month, above forecasts for 103.0 and up from a reading of 103.2 in October. The Current Assessment Index increased to 110.0 in November, beating expectations for a reading of 108.0 and up from 108.4 in October.
