Base Metal Related News

Base Metals upside fizzles as gains remained capped driven by the release of weaker-than-expected economic data out of China.

China produced 77.62 million mt of crude steel in November, 10.8% higher than November 2017

Total approved copper scrap imports this year at 999,700 mt, down some 66.7% from the overall volumes approved last year. A total of 3.01 million mt of copper scrap imports got approved in 11 batches in 2017.

Growth in China's new home prices slowed in November as markets in smaller cities lost some of their heat, though the sector remained relatively resilient amid a broader slowdown in economic activity.

Meanwhile at China's policy-setting meeting, the government is expected to take greater steps to ensuring economic stability where key growth targets and policy goals for 2019 will be discussed.

Base Metal prices are trading negative today. We expect metal prices to trade supportive ahead of major policy announcements and economic outlook from US and China. Any dovish language in the FOMC statement which points to a slower rate of interest rate increases could fuel weakness in the dollar, and thus be supportive to base metals prices.
