the dollar rallied from a two-week low and benchmark U.S. Treasury yields lipped to seven-week lows as stock market declines boosted global lemand for safe-haven U.S. Treasury debt and the dollar.

Investors are now keeping a close eye on a Group of 20 leaders' summit later this month in Argentina where U.S. President Donald Trump is expected to meet with Chinese President Xi Jinping to discuss the bilateral trade dispute.

According to a Reuters poll published, median forecasts show three more increases next year, taking the federal funds rate to 3.00-3.25 percent by end-2019. But the third rate rise is a close call.

Precious metals are trading slightly negative in early trade.
