Base Metal prices rose after U.S-China trade talks resumed while investors awaited minutes from the U.S. Fed on clues on policymakers' thinking on interest rates and its balance sheet reduction policy

The Fed judged that a 'patient' approach to interest rate hikes is the best path forward.

Copper prices have found support from of a number of recent supply-side developments and rising demand in China following the Lunar New Year holiday.

Chinese and U.S. negotiators are said to be working on multiple memorandums of understanding as part of a trade deal as talks continue in Washington this week.

Production of copper cathode by Hindalco, Hindustan Copper and Vedanta slides to 379,292 tons in April- January from 698,992 tons in the year-earlier period, according to the nation's Mines Ministry.
