Base Metal Related News

Base Metal prices remained steady as low stocks and as investor waited for fresh direction from the US-China trade deal.

Rusal sees demand growth averaging 3.7 percent in 2019 compared with 3.6 percent a year earlier.

China's demand for copper and zinc to be "very strong," driven by consumption in electric vehicles and battery storage facilities, as well as positive economic growth targets, according to miner MMG Ltd.

China's top steelmaking region of Hebei will cut 14 million tonnes of annual steelmaking capacity both this year and next year as it strives to improve air quality, the province's Communist Party head said on Thursday.

The focus will be on the European Central Bank interest rate decision, monetary policy statement and press conference as well as further US employment data with initial jobless claims.
