Base Metal Related News

Base Metal prices edged lower, as investors worried about the prospect of a recession in the United States, the world's biggest economy.

China said it's scaling back subsidies on electric vehicles to encourage local manufacturers to rely on innovation rather than government assistance as the industry matures and costs fall.

U.S. and Chinese officials resume high-level trade talks this week as they close in on a deal that could just be the first step in the long road to economic peace.

Chinese industrial profits fell by 14% year on year in January-February 2019. This compares with a 10.3% year-on-year increase in December 2018.

Zinc stocks at SHFE warehouses declined by 8,064 tonnes, meanwhile, LME zinc stocks were at 56,425 tonnes on March 26, down from 129,000 tonnes at the beginning of the year.
