Base Metal Related News

Base Metal prices rose after a senior U.S. official expressed optimism about progress in the scheduled trade talks with China this week.

Concern about copper supply disruption returned after an indigenous community in Peru, which has been blocking roads to Las Bambas copper mine, refused to negotiate with the government.

The Caixin/Markit services purchasing managers' index (PMI) rose to 54.4, the highest since January 2018 and up from February's 51.1, a fourthmonth low.

Christine Lagarde said that rising trade tensions, concerns over Britain's exit from the European Union and tougher financial conditions as central banks raised interest rates had "increasingly unsettled" the world economy.

Chinese Vice Premier Liu He will resume negotiations with his U.S. counterparts in Washington on Wednesday as both governments push for an agreement to end their protracted trade dispute.
