Base Metal Related News

Base Metal prices rose after U.S. President Donald Trump insisted that trade talks with China had not collapsed.

Average new home prices in China's 70 major cities rose 0.6% in April, unchanged from the pace of growth in March.

Trump is expected to delay a decision on tariffs on imported cars and parts by up to six months.

Nickel stocks in London Metal Exchange warehouses totaled 167,268 tonnes on Wednesday, a fresh six-year low.

Almost 70% of capacity across small secondary lead smelters in Guangdong has been forced to suspend.

Xinfa Group, one of China's biggest aluminium smelters, is closing all production lines on its 2.8-million-tonne-per-year alumina refinery in Shanxi for an unidentified period, amid an environmental dispute
