Gold prices rose to remain on track for their first monthly gain since January, with expectations of cuts in U.S. interest rates boosted by inflation data for the first quarter.

Markets were also keeping a close eye on international trade tensions, with U.S. President Donald Trump's shock move to slap tariffs on Mexico risking tipping the United States, and maybe the whole world, into recession.

China's factory activity shrank more than expected in May, an official survey showed on Friday, heaping pressure on Beijing to roll out more stimulus to support an economy hit by a bruising trade war with the United States.

(ields on the 10-year Treasury note quickly fell to a fresh 20-month low of 2.18%, while the dollar jumped 1.7% on the Mexican peso.

Federal Reserve Board of Governors Vice Chair Richard Clarida had said the central bank would act if inflation stays too low or global and financial risks endanger the economic outlook.
