Energy Related News

Oil prices fell after Trump said U.S. would impose tariffs on all Mexican goods, opening up a new front in the trade war and damping the demand outlook.

OPEC pumped 30.17 million barrels per day (bpd) in May, the survey showed, down 60,000 bpd from April and the lowest OPEC total since 2015.

In May, the 11 OPEC members bound by the agreement achieved 96 percent of pledged cuts, the survey found, compared to 132 percent in April, due to the rise in production in Saudi Arabia, and increases in Iraq and Angola.

Saudi Arabia boosted supply by 200,000 bpd to 10.05 million bpd, the survey found. This is still below its OPEC quota of 10.311 bpd.

American oil inventories fell by 282,000 barrels last week compared with the median forecast for a 1.36 million barrel decline in a Bloomberg survey.
