### **Base Metal Related News**

Base Metal prices fell as weak Chinese factory data and a U.S. threat to impose tariffs on Mexican goods sparked fears of weaker global growth and demand for metals.

Factory activity in China, the world's largest consumer of metals, slumped in May to a deeper contraction than expected.

Chile's state-owned miner Codelco said it partially halted work at its biggest copper mine El Teniente following a fatal accident.

China's Caixin manufacturing PMI for May came in at 50.2, flat with the prior month but beating an expected reading of 50.

Zinc's cash-June spreads are now in a \$41-per-tonne backwardation and its June-July spreads are in a \$58-per-tonne backwardation.

Copper concentrate treatment and refining charges went up marginally in late May from record low levels on May 24.
