Base Metal Related News

Base Metal prices traded in tight range amid a lack of progress in the prolonged U.S.-China trade war and weak manufacturing data that sparked concerns of slowing global growth and demand for metals.

Top aluminium producers have offered Japanese buyers premiums of \$115-\$120 a tonne for July-September primary metal shipments, up 10%-14% from the current quarter.

Transactions of spot zinc improved in Shanghai as downstream consumers stockpiled after prices of futures extended their declines.

In the refined market, global exchange inventories (London Metal Exchange, SHFE, Comex) dropped by around 77,000 tonnes or 16% last month.

Employees at the Chuquicamata division of Chilean copper miner Codelco have continued to work while trying to secure a deal with the company, despite having voted for industrial action.
