Base Metal Related News

Base Metal prices were mostly down with concerns of a global economic slowdown weighing on the complex with the dollar.

Nyrstar has halted production at the Port Pirie lead smelter in Australia and declared force majeure on shipments to customers after an unexpected outage.

The refined nickel market deficit is expected to nearly halve to around 80,000 tonnes this year from almost 150,000 tonnes in 2018, the International Nickel Study Group said on Wednesday June 5.

The weakening of the dollar came after United States Federal Reserve chairman Jerome Powell hinted of a willingness to lower interest rates on Tuesday.

The IMF downgraded its prediction for Chinese economic growth in 2019 to 6.2% having only raised it to 6.3% two months ago. The forecast is still within Beijing's growth target range of 6-6.5%.
