Oil prices rebounded as reports that Washington may engage more with its trade foes eased fears of slumping crude demand.

Trump said he will decide on enacting tariffs on another \$325 billion in Chinese imports after meeting.

Russia had differences with OPEC over what constituted a fair price for oil, but that Moscow would take a joint decision on output at a policy meeting in coming weeks.

Saudi Energy Minister Khalid al-Falih told an industry conference in St. Petersburg, Russia, that \$60 a barrel was too low to encourage investment in the industry.

Iraqi Oil Minister Thamer Ghadhban said on Friday that OPEC and its allies were most likely to extend their global oil output deal until the end of the year
