Base Metal Related News

Base Metal prices rises after Washington struck a deal to avert a tariff war with Mexico, boosting sentiment on trade and helping ease concerns about a global slowdown.

China's exports unexpectedly returned to growth in May, but imports fell in a further sign of weak domestic demand that could prompt Beijing to step up stimulus measures.

China, the world's largest rare earth exporter, sold 3,640 tonnes of rare earths in May, down 15.9 percent from April.

China's nickel pig iron daily output fell for 1st time in 5 months in May as environmental checks curtailed production.

China's imports of unwrought copper and products slumped to 361,000 tons tons in May, down 23% from a year earlier and 11% lower than April.
