### **Base Metal Related News**

Base Metal prices rose on hopes that China would increase spending for metal-intensive infrastructure projects, but a festering trade war between Beijing and Washington curbed further gains.

Premiums for nickel in the physical market, paid above the LME benchmark price, in China have languished around \$235 a tonne since early May, while those in Europe at around \$225 a tonne have been falling since April.

Trump struck a slightly more positive tone on the U.S.-China trade war but again threatened to increase tariffs on Chinese goods if no deal is agreed.

Former Foreign Secretary Boris Johnson, launched his Conservative party leadership bid with a promise to take Britain out of the EU on October 31, with or without a deal.

Chuquicamata mine Unions Nos. 1, 2 and 3 rejected Santiago-based Codelco's last offer for a collective contract at a meeting on Wednesday.
