# **Energy Related News**

Oil prices jumped as much as 4% on Thursday after a suspected attack on two tankers in the Gulf of Oman near Iran and the Strait of Hormuz.

The tanker Kokuka Courageous sailing from Saudi Arabia to Singapore with a cargo of methanol "has been damaged as a result of the suspected attack," the vessel manager said in a statement.

The EIA also said inventories at Cushing, the largest American storage hub, rose by 2.1 million barrels, the biggest increase since mid-February.

The Iranian state news media reported that multiple tankers had been seriously damaged. A shipping industry official, said at least two tankers had been hit.

The Marshall Islands-flagged Front Altair carrying naphtha and the Panamaflagged Kokuka Courageous carrying methanol have been evacuated and the crews were safe, shipping sources said.
