## **Energy Related News**

Oil prices held losses as OPEC and its allies continue to struggle to set a date to discuss an extension to supply cuts and as U.S. economic indicators signal weakening demand.

Iran's Oil Minister Bijan Namdar Zanganeh said he was willing to holds talks in July, one week later than the timing proposed by other group members.

OPEC group needs to agree on whether to keep restraining oil production for the rest of the year as crude demand shows signs of weakening.

U.S. crude oil inventories likely fell last week after rising for two consecutive weeks, while refined products were seen rising slightly, a preliminary Reuters poll showed on Monday.

Putting further pressure on oil, the U.S. energy department said on Monday that shale oil output is expected to reach a record in July.
