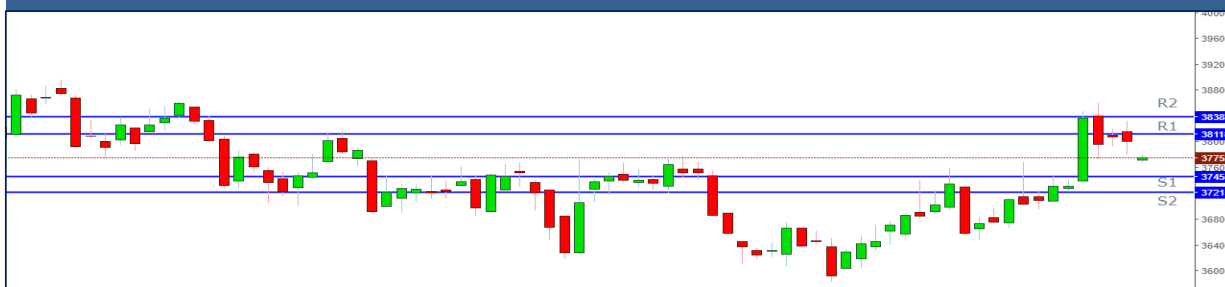
Precious Metal Outlook
