The Druzhba oil pipeline section that runs from Belarus's Mozyr refinery to Poland has been fully cleared of contaminated oil.

Russian Energy Minister Alexander Novak said on Friday he hoped a meeting of G20 nations in Japan would provide clarity for OPEC and non-OPEC oil producers as they consider whether to extend a deal on cutting crude supplies beyond June.

Oil prices higher as investors weighed mixed signals from the US on Iran and signs that an extension of the OPEC+ production cuts may not be done deal

Trump wants to talk to partners and allies to get their support for his Iran sanctions program and to talk about how to encourage Iran to enter into diplomatic negotiations after Tehran shot down an American drone last week.
