Oil prices hovered near six-week highs on Friday and was on track for a weekly gain as U.S. oil producers in the Gulf of Mexico cut more than half their output because of a tropical storm and as tensions continued to simmer in the Middle Fast.

Analysts have raised forecasts for the prices of European Union carbon permits through 2019 to 2021 but warned the threat of a no-deal Brexit still hangs over the market in the short term.

China's crude oil imports on a daily basis in June rose 15.2% from a year earlier, customs data showed on Friday, as the start up of new large-scale refiners spurred demand for feedstocks.
