Base Metal Related News

Base metals prices on the Shanghai Futures Exchange mostly drifted lower during morning trading on Wednesday July 17, with the complex coming under pressure from strength in the dollar and growing risk aversion stemming from US-China trade tensions.

One of the prevailing China narratives in commodity markets is that the trade dispute with the United States is weakening demand in the world's biggest importer of natural resources. The problem is the numbers tell a somewhat different story.

The Midwest aluminium premium in the United States fell to its lowest point since March 2018 last week, while premiums in other global areas were steady, with markets in every region except Japan showing a lack of liquidity.
