Base Metal Related News

Base Metal prices advanced on Wednesday amid reports of progress in trade negotiations between the United States and China.

Larry Kudlow said on Tuesday it was a good sign that top U.S. officials would be travelling to China to discuss reviving stalled trade talks, and said he expected Beijing to start buying U.S. agriculture products soon.

China's central bank governor Yi Gang said the country's current interest rate level is appropriate, the financial magazine Caixin reported on Tuesday.

Aluminium producer Norsk Hydro has managed to ramp up operations at its Alunorte refinery in Brazil despite a cyber attack in March, the firm said.

China's yuan weakened in thin trade on Wednesday as investors awaited clearer signals on U.S. China trade talks and monetary policy decisions from major global central banks.
