## **Base Metal Related News**

Base Metal prices fell ahead of planned trade talks between U.S. and Chinese officials.

China's Industrial profits fell 3.1% in June from a year earlier to 601.9 billion yuan according to data released by the NBS following a 1.1% gain in May.

Rusal reported a 21% rise in second quarter aluminium sales compared to the previous quarter, as the Russian aluminium giant's recovery from 10 months under U.S. sanctions accelerated.

Donald Trump offered a pessimistic view on reaching a trade deal with China, saying Beijing may try to delay reaching a trade deal until the 2020 election.

Trade negotiators from the United States and China will meet in Shanghai this week for a two-day discussion aimed at resolving the year-long trade war between the world's two biggest economies.
