Oil prices ticked lower as concerns about oversupply overshadowed worries about supply disruption due to geopolitical concerns in the Middle East.

An emergency meeting with parties to Iran's 2015 nuclear deal was constructive but there are unresolved issues and Tehran will continue to reduce its nuclear commitments if Europeans fail to salvage the pact, Iranian official said .

The U.K. has sent one of its Type 45 warships to the region after Iran seized a British oil tanker as the U.S. seeks to build a coalition to protect vessels traversing the strait.

China's purchases of oil from Saudi Arabia rose to a record of 7.72 million tons in June, up from 4.7 million tons in May.

Working oil rigs in the U.S. fell by three to 776 last week, the fourth straight weekly decline, according to data released by Baker Hughes.
