## **Base Metal Related News**

Base Metal prices coming under pressure from heightened US-China trade tensions and stock inflows at the end of last week.

Shanghai nickel prices jumped in the morning of Monday August 5, bolstered by renewed concerns over Indonesia's export ban on nickel ore.

Eurozone growth softens as manufacturing downturn deepens.

China's yuan weakened beyond the key 7-per-dollar threshold in a move that threatens to lead to massive capital outflows.

China's retail sales of passenger vehicles in the first four weeks of July shrank 16% from the same period a year ago, compared with a year-over-year rise of 5% in the first four weeks of June.

SHFE copper stocks totaled 155,971 tonnes on Friday after accounting for a 6,782-tonne inflow.
