Base Metals hovering around a two-year low, as a year-long U.S.-China trade war escalated and the Chinese offshore yuan fell to an all-time low.

Larry Kudlow told CNBC that the Trump administration wants to continue talks with China and was still planning to host a Chinese delegation for talks in September

China's exports probably fell for a second successive month while imports likely contracted more sharply in July, a Reuters poll showed, hurt by tit-fortat tariffs in a rapidly escalating trade war with the United States.

Trump pledged to stand with American farmers in the face of Chinese retaliation, after Beijing halted U.S. agricultural purchases

According to data from China's National Bureau of Statistics, zinc output in China surged by 10.3% year on year in June to 513,000 tonnes. This was up by 6.9% from the 480,000 tonnes produced in May.
