Base Metal Related News

Base Metals prices were almost unchanged as the short-term relief arises on expectation of central bank easing.

Traders are also awaiting the central bank's annual Jackson Hole seminar later this week and a Group of Seven summit this weekend for clues on what additional steps policymakers will take to boost economic growth.

Trump said he had to confront China over trade even if it caused short-term harm to the U.S. economy.

Trump said his administration was considering potential tax cuts on wages as well as profits from asset sales, and sought to play down market anxieties that the world's top economy could be heading for a recession.

Global primary aluminium output rose to 5.405 million tonnes in July from revised 5.275 million tonnes in June, data from the IAI showed on Tuesday.

Demand for refined copper exceeded new supplies by 190,000 tons in the first five months of 2019, says the International Copper Study Group.
