Base Metal Related News

Base Metals prices were down as U.S. policy makers sounded conflicted on whether to cut interest rates as sharply as markets were wagering.

The minutes of the Federal Reserve's July meeting showed policymakers were deeply divided over whether to cut interest rates as sharply as markets were wagering.

Trump said he had to confront China over trade even if it caused short-term harm to the U.S. economy.

Fastmarkets assessed the nickel, min 99.8%, full plate premium, cif Shanghai at \$150-180 per tonne on Tuesday, down from \$170-190 per tonne amid a closed import window and widened arbitrage loss.

The global nickel market deficit narrowed to 5,100 tonnes in June from a revised shortfall of 12,400 tonnes in the previous month

The global zinc market swung into a 10,900 tonne surplus in June from a revised deficit of 38,200 tonnes in May, data from the ILZSG said.
