Oil steadied after its first drop this week as attention turned from expanding American fuel stockpiles to the prospects for monetary easing as the world's top central bankers gather in Jackson Hole.

U.S. crude inventories fell by 2.7 million barrels last week, the first drop in three weeks.

If Iran's oil exports are cut to zero, international waterways will not have the same security as before, Rouhani said. Iranian Foreign Minister Mohammad Javad Zarif said Tehran might act "unpredictably" in response to U.S. policies under President Donald Trump.

Minutes of the Federal Reserve's July meeting showed policymakers were deeply divided over whether to cut interest rates as sharply as markets were wagering.
