Oil held losses as the U.S. and China's inability to agree on a schedule for trade talks worsened demand pessimism.

American Petroleum Institute stocks fell last week by 7.2 million barrels, more than twice the amount analysts in a Reuters poll had forecast.

Prince Abdulaziz bin Salman, Saudi Arabia's new energy minister, said the kingdom's oil policy would not change.

Trump abruptly fired Bolton amid disagreements over how to handle foreign policy challenges such as North Korea, Iran, Afghanistan and Russia.

In its latest monthly Short Term Energy Outlook, the EIA reduced its forecast for spot West Texas Intermediate crude prices for 2019 to an average of \$56.31/bbl.
