Base Metals prices fell on Tuesday after top consumer China released a slew of weak economic data that raised concerns about demand

Trump said his administration could seal a deal on trade with China before the U.S. presidential election, or an agreement could be reached the day after U.S. voters go to the polls

China's new home prices growth slowed to 8.8% in August from the 9.7% gain in July, marking the weakest pace since October 2018.

China's zinc output rose 18.9% from a year earlier to 528,000 mt in August, the highest monthly production since December 2017

ShFE lead fell as much as 1.9% on rising supply outlook after Nyrstar said it had temporarily reopened an old lead-processing plant in Australia.

Philippine nickel miners are likely to ramp up ore output by next year, but their production capacity is limited by several factors.
