## **Base Metal Related News**

Base Metals prices prices edged higher in early trade, after U.S. Treasury Secretary Steven Mnuchin said he would meet with Chinese Vice Premier Liu He for trade talks in two weeks.

Chinese importers bought about 10 boatloads of U.S. soybeans on Monday following deputy-level trade talks in Washington last week.

The global world refined copper market showed a 21,000 tonnes deficit in June, compared with a 70,000 tonnes deficit in May

An explosion has occurred at a 500,000-tonne-per-year aluminium smelter owned by Chinese investment firm East Hope Group, market sources told.

Nornickel forecast a deficit of 28,000 tonnes in 2020 from an estimated deficit of 60,000-70,000 tonnes in 2019.

BoJ Gov Kuroda said no need to rule out any policy option, including deepening of negative rates.
