Base Metal Related News

Base Metals prices edged lower tracking worries over US-China trade war and its impact on global health which already is showing signs of slowdown.

Donald Trump at the United Nations General Assembly in New York on Tuesday, in which he said he would not accept a "bad deal" with China.

Five private copper smelters in China have halted production because processing at market terms has become unfeasible due to a combination of weakening demand for end products.

Fastmarkets assessed the nickel, min 99.8% full plate premium, cif Shanghai at an unprecedented discount of \$50-0 per tonne on Tuesday, having been at a premium of \$140-160 per tonne.

China is in no rush to follow other countries in significantly loosening policy but has ample options to help prop up slowing growth, its central bank said, maintaining a cautious approach to stimulating the economy.
