Base Metals prices mixed ahead of US employment report and next week's

The Shanghai Futures Exchange was closed on Thursday as part of its Golden Week Holidays and will reopen on Tuesday Oct. 8.

The metals are likely to now start to focus on next week's US-China trade talks whether the optimism leads to a pick-up in sentiment, or whether investors decide to wait and see.

Nickel headline inventories in LME-approved warehouses dropped to 140,904 tonnes, their lowest since December 2012.

Chile's Antofagasta negotiated with workers in hopes of staving off a strike at its small Antucoya deposit in northern Chile, though union leaders said there had been little progress in discussions.

A key U.S. factory index fell to a 10-year low on Tuesday as businesses held back investments amid tariffs and the U.S.-China trade war.
