Base Metal Related News

Base Metals prices rise after reports that the United States is weighing a currency pact with China as part of a partial deal that could see a planned tariff hike next week being suspended.

China has lowered expectations for significant progress from this week's trade talks with the United States, Chinese government officials told Reuters, even as Trump expressed fresh optimism.

Operations at Las Bambas will be affected by road disruption with supplies being blocked amid anti-mining protests, Chinese miner MMG Ltd said.

China's cabinet unveiled steps to ease growing fiscal strains on local governments, amid a push to cut taxes to support the slowing economy.

A shortage of aluminium in China as domestic supplies fall has boosted prices in Shanghai, which are outperforming those on the LME where weaker demand in the rest of world is reflected, a divergence expected to dominate for some time.

However, on the other side there are high expectation of further interest rate cut in future meeting. Market participants will continue to look for cues from the US-China trade talks as any partial trade deal will remain positive for base metal prices.
