Base Metal Related News

Base Metals prices rise after Trump said he would meet with China's top trade negotiator, but London prices treaded water as investors remained cautious ahead of the final day of trade talks.

China's exports fell by 3.2% more than expected while imports fell by 8.5%, well below the 6.0% decline expected.

Reports indicated that the EU and U.K. were entering "more intense" discussions of U.K. Prime Minister proposals to avoid a disorderly Brexit.

NEV production and sales in China stood at 89,000 units and 80,000 units in September, respectively, down 29.9% and 34.2% from September 2018. The decline in sales expanded from a 15.8% drop in August.

China's exports of unwrought aluminium and aluminium products stood at 435,000 mt in September, down 14.2% from September 2018.

For the first nine months of 2019, sales came in at 15.03 million units, down 8.6% from the same period last year.
