Oil prices fell as two days of weak Chinese data added to worries about the top crude oil importer's energy demand growth.

Hedge fund bets on a WTI crude rout jumped 47% in the week ended Oct. 8, following surges of more than 30% in the previous two, data released .

Saudi Arabia's oil production will recover in October and November to levels above those seen before attacks on its energy installations in September, energy minister Prince Abdulaziz bin Salman said on Monday.

The NBS reported that China's factory gate prices declined at the fastest pace in more than three years in September.
