Base Metal Related News

Base Metals prices little changed as market participants continue to digest developments in United States-China trade negotiations.

Copper prices dipped as Chile's Antofagasta Minerals, one of the world's top copper producers, averted a labour strike at a copper mine after reaching an agreement with its employees.

Kazakhstan's output of refined copper rose 11% in January-September to 354,836 tonnes, while refined zinc output was down 0.9% during the same period to 235,914 tonnes.

Shanghai nickel SNIcv1 fell to as low as 131,750 yuan a tonne, its lowest since Aug. 30, amid weak demand from both the stainless steel and electric-vehicle sectors.

Asian shares took off and sterling held near six-month highs as Britain and the EU made headway on a Brexit deal ahead of a leaders' summit though it remained unclear if could avoid postponing its departure on Oct. 31.
