Base Metal Related News

Base Metals prices were broadly down with copper and aluminium securing marginal gains while the rest of the complex weakened.

The BOJ is considering lowering its forecasts for economic growth and inflation this year in a quarterly outlook report to be released.

China's imports of nickel ore increased 24% from a month ago and 23.16% from a year ago to stand at 7.09 million mt in September.

Global nickel demand is expected to increase to 2.52 million mt in 2020, from 2.45 million mt in 2019, said International Nickel Study Group (INSG).

Premiums for copper cathode on a cif basis in China were unchanged over the past week amid limited spot activity due to a closed arbitrage window for copper cathode imports into the country.

Nickel stocks in LME fell to 87,132 tonnes, hovering around their lowest since November 2011, latest data showed, while ShFE inventories rose.
