Gold prices unchanged on prospects of a delay in the U.S.-China trade pact, while cautious investors awaited the Federal Reserve's decision on interest rates later in the day.

Britain will hold its first December election in almost a century after Prime Minister Boris Johnson won approval from parliament on Tuesday for an early ballot aimed at breaking the Brexit deadlock.

Meanwhile, an interim trade agreement between the United States and China might not be completed in time for signing in Chile next month as expected but that does not mean the accord is falling apart, a U.S official said.
