Base Metals prices down on dwindling confidence of a long-term trade deal being struck between the United States and China weighing on the complex.

The United States and China both said on Friday that they had made progress in talks aimed at defusing their protracted trade war, and U.S. officials said a deal could be signed this month.

The difference between the LME aluminium cash and three month contracts flipped to a premium for the first time since January to \$4.75 a tonne, indicating tight nearby supplies.

US Commerce Secretary Wilbur Ross said on Sunday that there was "no natural reason" why a "Phase One" trade deal with China could not be reached this month.

SHFE aluminum inventories declined by 16,101 tonnes or 5.5% to 278,736 tonnes as of November 1, while zinc stocks fell by 2,276 tonnes or 3.6% to 61,799 tonnes.
