Base Metal Related News

Base Metals prices down on dwindling confidence of a long-term trade deal being struck between the United States and China weighing on the complex.

Chinese offshore Yuan strengthens past 7 against the dollar; for the first time since August.

China's central bank cut the interest rate on its medium-term lending facility for the first time since early 2016, as policymakers work to prop up a slowing economy hit by weaker demand at home and abroad.

Copper miner Antofagasta has cut its 2019 copper production guidance by 10,000 tonnes after demonstrations and unrest in Chile.

China is pushing Trump to remove more tariffs imposed in September as part of a "phase one" U.S.-China trade deal.

China's services sector activity expanded at its slowest pace in eight months in October as new orders slowed and business confidence hit a 15-mth low.
