Oil jumped as China and the U.S. made progress in resolving the trade dispute that has weighed on global markets this year, offsetting signs that OPEC and its partners won't make deeper cuts to supply.

The biggest producers in OPEC+ aren't pushing for deeper oil-supply cuts when the group meets next month.

China and the U.S. have agreed to proportionally roll back tariffs on each other's goods in phases, a Chinese Ministry of Commerce spokesman said.

U.S. crude inventories surged by 7.9 million barrels last week, almost four times more than the median estimate in a Bloomberg survey.

Russia's Energy Minister Alexander Novak said on Wednesday that the market is rather balanced and a Brent price of more than \$60 indicated that the situation is stable.
