Base Metals subdued after United States President Donald Trump said a "complete rollback" was off the table.

China's consumer price index rose by 3.8% year on year in October, outstripping the expected 3.2% increase. The producer price index fell by 1.6% over the same comparison, slightly more than forecast 1.5% decline.

Beijing and Washington have agreed to roll back tariffs on each others' goods if a "phase one" trade deal is completed, officials from both sides sai

Retail sales of passenger vehicles in China fell in October for a fourth straight month, declining 6% from a year earlier to 1.87 million units.

Wholesale sales of NEVs in China dropped 45.4% from a year ago to 66,000 units last month, showed data from the industry association.

Indonesia has lifted the temporary suspension on mineral ore export that was implemented two weeks ago and announced to stick to the 2020 deadline for the export ban.
