Precious Metals News

Gold prices edged down bullion's safe-haven appeal was dented by hawkish signals from the U.S. Federal Reserve on further interest rate cuts, citing growth in the U.S. economy, a strong labour market and steady inflation.

U.S. Fed Powell said the negative interest rates sought by President Donald Trump were not appropriate for the U.S. economy right now.

Trump threatened to jack up tariffs on Chinese goods if the countries fail to reach a trade deal, which could raise the price of cellphones, laptops, and toys less than two weeks before Christmas.

The political unrest in Hong Kong has also supported gold, which is considered an alternative investment during times of geopolitical and financial uncertainty.

SPDR Gold Trust GLD, the world's largest gold-backed exchange-traded fund, said its holdings fell 0.04% to 896.77 tonnes on Wednesday from 897.09 tonnes the previous session.

Precious Metal Outlook

Precious metals are trading higher in the morning trade. We expect prices to trade higher on political tensions in Hongkong and after Trump threatens to hike China tariffs if the countries fail to reach the agreement before Dec 15. One can maintain buy on dips in Gold for the day.
