Base Metal Related News

Base Metals fell in the early trade amid continued uncertainty about the sealing of a trade deal between the top two economies.

Trump agreed over progress of completing an initial trade deal with China "soon," but offered no new details on negotiations.

China's industrial output grew 4.7% yoy in October, down from 5.8% previously. Chinese retail sales also slowed last month with a 7.2% yoy.

The Indonesia nickel miners association said on Wednesday the antimonopoly body has launched an investigation into alleged cartel practices affecting pricing by local smelter operators..

China's aluminum consumption is seen falling for the first time in 30 years this year as both domestic demand and exports decline, research house Antaike said on Wednesday.

China's production of new energy vehicles stood at 85,000 units in October, down 39.7% from a year ago and 9.6% from a month ago, according to NBS
